## **TEIGNBRIDGE DISTRICT COUNCIL**

in respect of

### **DOG BYELAWS IN PLAY AREA IN THE RECREATION GROUND ASHBURTON**

Byelaws made by Teignbridge District Council under section 164 of the Public Health Act, 1875 and all other powers them enabling with respect to a pleasure ground.

#### EXTENT

1. (1) These byelaws apply to part of a pleasure ground described in the Schedule and hereafter referred to as 'the play area'.
- (2) Notice of the effect of these byelaws shall be given by signs placed in conspicuous positions in or near the play area.

#### INTERPRETATION

2. (1) In these byelaws, 'the Council' means Teignbridge District Council.
- (2) For the purpose of these byelaws the keeper of the dog shall be deemed in charge thereof, unless the dog had been placed in or taken into the charge of some other person at the time when an offence under these byelaws had been committed.
- (3) In paragraph (2) above 'the keeper' shall include the owner of the dog or any person who habitually has it in his possession.

#### DOGS PROHIBITED FROM THE GROUND

3. (1) No person (other than a registered blind person) in charge of a dog shall, without reasonable excuse, permit the dog to enter or remain in the play area.
- (2) An officer of the Council or any constable may require a person in charge of a dog which has entered the ground to remove the dog from the play area.

#### REMOVAL OF OFFENDERS

4. Any person offending against byelaw 3(1) may be removed from the play area by any officer of the Council or any constable.

#### PENALTY

5. Any person offending against byelaw 3(1) shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale.

#### REVOCATION

6. Byelaws made by Teignbridge District Council on 1<sup>st</sup> October 1996 and confirmed by the Secretary of State on 30th August 1996 insofar as they affect the play area are hereby revoked.






